Clause 0: Competition

Athletic competition *W.A.S.I.C.* aims the confrontation among budoka in all the martial and fighting arts with the purpose of achieving not only the most real, free and independent budo but also the meeting and union among people.

Clause 1: Phases

The athletic competition will be divided in **a single phase**.

All kinds of performance, both individual and in pairs, connected to all the martial styles, are approved.

They can be shown individually, in pairs, in team.

With "performance" we mean:

- \rightarrow Form
- \rightarrow Fight
- \rightarrow Demonstration
- \rightarrow etc.

It will be effective from the issue of the public announcement of "start competition" at the

beginning of the year until the 25th October.

During this period, every athlete will send to the referential email address a:

- → video in which they perform a form/fight/performances/demonstration of their own martial or fighting art,
- \rightarrow **form**, carefully filling out all required fields in which they state:
 - ✓ name/surname
 - ✓ nationality
 - ✓ age
 - ✓ sex
 - \checkmark practiced style
 - ✓ practice years
 - ✓ referential master
 - \checkmark additional information about their style in case it is a new one.

This phase is:

- \rightarrow graded,
- $\rightarrow\,$ divided according to discipline/category.

All videos will be judged by the assigned Technical Judging Commission.

Clause 2: Competitors

All members of **U.I.K.J.**, who refer to a recognized school led by a Master, are eligible.

All others will first attend a seminar U.I.K.J.

Their categorization will depend on their:

- \rightarrow style
- \rightarrow category
- \rightarrow sex

Clause 3: Technical Judging Commission

The athletic competition will be judged by a chosen and led by **GM° Roberto LATINI**.

The Technical Judging Commission will be composed of at least 3 voting judges.

Clause 4: Frequency

The competition will be held every year and will be divided into 3 phases.

Clause 5: Official uniform

The athlete have to wear the official uniform of the practiced discipline.

In the front they can show the original labels and on the upper left they can exhibit the society badge.

Clause 6: Competitions planning

The competition can be individual or in teams.

The competitions in teams occur in different formations, each one made of male or female athletes.

By necessity, the teams can be made of both male and female athletes.

Clause 7: Decision criteria

When judging the performance of a single athlete or a team, judges will consider the following elements:

- agility and rigor
- realistic communication of the meaning
- comprehension of the used techniques
- timing, rhythm, speed, balance and application of power
- correct use of breathing
- martial spirit
- correct positions
- look in the technique specific direction
- suitable abdominal strength with proper use of hips in all the different techniques
- correct performance according to the practiced style
- synchronization
- proper use of strength

Clause 8: Penalties

In the final score, judges will have to subtract:

- for a little hesitation immediately fixed 0.1 points
- for a more evident pause (longer than 5-7 seconds) 0.2 points
- for a momentary loss of balance immediately fixed from 0.1 up to 0.2 points
- for a lack of a non fundamental technique **0.3 points**
- for a serious loss of balance or fall from 0.3 up to 0.5 points
